Privacy Collection Notice and Consent

The Riverina Cooperative Society Limited ABN 22748 372 499 ('we', 'our') are committed to protecting your privacy. This form outlines how we collect, use, and protect your personal information in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles (APPs). By signing this consent form, you acknowledge and agree to the collection, use, and disclosure of your personal information as described below.

1. Collection of Personal Information

We collect personal information from you to provide services, process transactions, and comply with legal obligations. The types of personal information we may collect include your name, address, contact information, ABN's, ACN, information relating to your enterprise and experience, as well as other marketing and preference information. We will collect your personal information only if it is necessary for our business functions and activities and to administer our services and transactions with you or where you have provided your consent.

2. Use of Personal Information

Your personal information will be used: to set up a membership with us and our respective legal obligations under the agreements we enter into; to collect and process payments and for debt recovery processes; and to comply with any legal or other internal or external obligations such as those relating to corporate governance, insurance, taxation, anti-money laundering, modern slavery and work health & safety. We will not use your personal information for any other purposes without your consent, unless required or authorised by law.

3. Disclosure of Personal Information

Your personal information may be disclosed to: service providers or contractors who assist in delivering our services; professional advisers; debt collection agencies; government agencies, credit reporting bodies, law enforcement, or regulatory bodies when required by law; and other third parties who are necessary for the performance of the services we provide or where you have provided implied or express consent. Information may also be disclosed, transferred, processed or used in other countries by us, or by third party service providers if certain business activities are outsourced overseas, IT servers are located in another country or where transactions, information or services are related to another country. We will ensure where reasonable that any third parties to whom we disclose your personal information comply with privacy laws and our privacy policy.

4. Data Retention

We will retain your personal information only for as long as it is required to fulfill the purposes for which it was collected or as mandated by law. When your personal information is no longer needed, we will securely destroy or de-identify it.

5. Your Rights and Choices

You have the right to: access and request a copy of your personal information held by us; request that your personal information be corrected if it is inaccurate; withdraw your consent at any time (subject to legal and contractual obligations) and opt out of receiving direct marketing communications. If you wish to exercise any of these rights, please contact us using the details below.

6. Security of Your Personal Information

We take reasonable steps to protect your personal information from misuse, interference, loss, unauthorized access, and disclosure. We implement appropriate safeguards, including physical, administrative, and technical measures, to secure your information.
